# <u>Call to order & roll call; welcome; review & approval of July 12, 2019 draft minutes (Action to be taken)</u>

GACA Chair, Lisa O'Neill, requested a delay in roll call due to lack of a quorum at 8:00 a.m. Executive Assistant, Lizette Cordero, conducted a roll call at 8:10 a.m. and based on a lack of a quorum, the Chair called for a recess until 8:20 a.m. The GACA Chair, Lisa O'Neill, called the meeting to order at 8:21 a.m. after Ms. Cordero conducted another roll call and a quorum was established. Chair O'Neill welcomed members and expressed appreciation for their participation.

# **Review and discussion of Sunset Review status**

#### Chair O'Neill reported:

- The Sunset Review Report template will be completed and distributed to council members by next week for their review/input before submitting the final report prior to the September 1, 2019 submission deadline.
- The GACA has received eight letters of support and two more drafts pending to be included in the Sunset Review Report.
- Chair O'Neill reminded one council member to submit his biography by end of next week to be included in the Sunset Review Report. All other council member's biographies' have been submitted to the Council Chair and will be included in the Sunset Review Final Report.
- Chair O'Neill notified council members she has unavoidable work related travel the last week of September and IF the Committee of Reference schedules meetings during that week she will not be available, and that 1 or 2 of the Executive Committee Officers will be expected to take charge in her absence.
- According to Chair O'Neill the GACA should get official word in October if the GACA will sunset or continue.

## Updates on office operations, staffing

Executive Assistant, Lizette Cordero, reported the Division of Aging and Adult Services (DAAS) has announced the appointment of a new DAAS Assistant Director, Molly McCarthy, effective August 5, 2019. Ms. Cordero also reported there is no word on the appointments of a GACA Executive Director or GACA Council Members.
